ORDINANCE NO. 11-08-2016-SOLAR

AN ORDINANCE AMENDING SECTION 21 OF ORDINANCE NO. SMC-05-10-11-SOLAR, SOLAR ENERGY FACILITY ORDINANCE RELATING TO THE ESTABLISHMENT OF ZONING DEVELOPMENT FEES OF THE ZONING DEVELOPMENT PERMIT FOR SOLAR FACILITIES.

WHEREAS, San Miguel County Ordinance No. SMC-05-10-11-Solar, Solar Energy Facilities Ordinance requires certain on-going revisions; and

WHEREAS, Section 21 of Ordinance SMC-05-10-11, Zoning Development Fees are not addressed; and

WHEREAS, Section 21 of Ordinance SMC-05-10-11 should be amended to address the Zoning Development Fees of larger commercial and public utility solar facilities.

IT IS NOW THEREFORE, ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF SAN MIGUEL COUNTY, NEW MEXICO, THAT,

Section 21. Compliance with Zoning Development Permit Process shall be amended as follows:

21.1. A fixed fee for a Zoning Development Permit shall be as follows:

One (1) megawatt facility	\$1,700.00
Two (2) megawatt facility	3,400.00
Three (3) megawatt facility	. 5,100.00
Four (4) megawatt facility	6,800.00
Five (5) megawatt facility or higher	8,500.00

All other provisions of the Ordinance shall remain in place.
